MEETING MINUTES

September 23, 2021

TIME AND PLACE

Upon notice duly given, a meeting of the Executive Committee (the "Committee") of the Business Law Section (the "Section") of the Oregon State Bar (the "Bar") was held by video conference on September 23, 2021, at 12:00 p.m. Pacific time.

PRESENT

Present were Committee members Anne Arathoon, Will Goodling, James Hein, Ben Kearney, Matt Larson, David Post, Charmin Shiely, Kara Tatman, and Tyler Volm. Also present at the invitation of the Committee were Joe Cerne (Chair, New Business Lawyers Subcommittee), Carole Barkley (Editor, *Oregon Business Lawyer*), and Susan Grabe (Bar representative). Committee members not in attendance were Jeffrey Tarr (Chair), Brian Jolly, Genny Kiley, Jennifer Nichols, Emily Maas, and Michael Walker.

Ms. Arathoon acted as Chair for the meeting in Mr. Tarr's absence and called the meeting to order at approximately 12:04 p.m. Pacific time. Mr. Goodling acted as Secretary and kept the minutes.

MINUTES

Ms. Arathoon reviewed the most recent meeting minutes with the Committee, and the Committee unanimously adopted the following resolution upon a motion duly made and seconded:

SUBCOMMITTEE REPORTS

CLE

Mr. Volm reported that the Section will host a standalone CLE to be presented by Natalie Pattison of Barran Liebman on October 21, 2021, via Zoom, regarding return-to-work legal issues. Mr. Volm further reported that the Section's upcoming annual CLE program would be hosted via Zoom over one day, with the date to be confirmed in the coming weeks.

Outreach

Ms. Arathoon noted that the Outreach Subcommittee had canceled a potential social event for the Committee due to COVID-19 considerations and guidelines.

Newsletter

Ms. Barkley reported that the Newsletter Subcommittee had recently published the September edition of the *Oregon Business Lawyer* and reported that authors have committed to write articles for the December edition.

New Business Lawyers

Mr. Cerne reported on a panel event that the New Business Lawyers Subcommittee recently hosted at the University of Oregon School of Law and a brief discussion followed.

Legislative

Ms. Tatman reported for the Legislative Subcommittee, including to note that the subcommittee provided a legislative update in the September edition of the *Oregon Business Lawyer*.

James B. Castle Leadership Award Subcommittee

Ms. Arathoon noted that no update was available regarding the James B. Castle Leadership Award with the subcommittee's members absent from the meeting.

Nominating and Member Recruitment Subcommittee
